- Provided aggressive, proactive customer outreach, matching customer needs with services provided by the NWS. Worked to improve services based on customer input.
- As the most active severe weather office in the NWS, issued hundreds of tornado, severe thunderstorm, and flash flood warnings.
- Worked with Emergency Managers and the Public to provide training on severe weather safety, with emphasis on a preparedness plan. Made hundreds of Storm Spotter Training presentations, and trained thousands of spotters.
- Received a personal Department of Commerce Gold Medal for developing a severe weather warning system and providing training on its use to deaf and hard of hearing residents of Oklahoma.

1985 to 1990 – Forecaster, National Weather Service, Chicago, Illinois

- Prepared public, aviation, and marine forecasts as well as tornado, severe thunderstorm, and flash flood warnings for a service area of 8,000,00 people in northeast Illinois and northwest Indiana.
